<p>Household goods - Diplomats or Semi Diplomats</p>	<ul style="list-style-type: none"> ▪ Sea and Air shipments - For diplomatic status: <ul style="list-style-type: none"> ▪ Front page passport - scan colour endorsed by embassy. ▪ Diplomatic ID card - scan colour endorsed by embassy. ▪ Stay permit/ITAS - scan colour endorsed by embassy. ▪ EPO stamp/Exit Permit Only (as soon as available) - scan colour endorsed by embassy. ▪ Recommendation Letter from Ministry of Foreign Department and the Diplomatic Note. ▪ Statement letter from shipper stating that he/ she is not bringing out any prohibited items - original. ▪ Power of Attorney letter/Surat kuasa signed by the client for the agent to handle this shipment - original. ▪ Reference letter from embassy which stating that client will move - original. 		<ul style="list-style-type: none"> ▪ Commence the clearance upon shipment arrival and receiving these docs. ▪ If client cannot provide all required paper works, the shipment cannot be custom clearance and released from the port on duty free basis.

Foodstuffs		<ul style="list-style-type: none"> ▪ Non-perishable food items may be exported in small amounts. 	
Alcohol		<ul style="list-style-type: none"> ▪ Export of alcohol is allowed for FULL DIPLOMATS ONLY but limited to annual quota agreed by the local Ministry of Foreign Affairs and the respective embassies in the country. Alcohol is prohibited for non-full diplomats. 	<ul style="list-style-type: none"> ▪ Including wine, spirits, and beer.
Prohibited Items		<ul style="list-style-type: none"> ▪ Firearms. ▪ Ammunition (including air guns). ▪ Pornography. ▪ Politically sensitive material. ▪ Narcotics. ▪ Illicit drugs. 	
CD's; DVD's; VCD's; Video/Audio tapes, books	<ul style="list-style-type: none"> ▪ Detailed listing at packing list as long not new and adult Video. 	<ul style="list-style-type: none"> ▪ Can be exported in 'reasonable' quantities provided they are not pornographic or politically sensitive or against Moslem.
