Vehicles (regular and diplomatic)	<ul style="list-style-type: none"> <li>▪ <b>Original</b> of the title of the vehicle (Registro Vehicular).</li> <li>▪ <b>Original</b> document of last revised of the vehicle (Último revisado).</li> <li>▪ Copy of the Panamanian Import customs declaration of the vehicle (If you have it) (Liquidación de importación rosada de aduana).</li> <li>▪ Copy of the insurance policy of the vehicle.                             <ul style="list-style-type: none"> <li>▪ Should be valid until the dispatch of the shipment.</li> </ul> </li> <li>▪ Copy of the commercial invoice of the vehicle.                             <ul style="list-style-type: none"> <li>▪ This is needed in absence of the import customs declaration.</li> </ul> </li> <li>▪ A notarized copy (black &amp; white, not in color) of the personal document mentioned in the title of the vehicle (Passport or Panamanian ID) of the owner of the vehicle.</li> <li>▪ Last Plate Receipt.                             <ul style="list-style-type: none"> <li>▪ The plate must be paid.</li> <li>▪ Copy of receipt of payment.</li> </ul> </li> <li>▪ <b>Original</b> certification of the Motor No. of the vehicle.                             <ul style="list-style-type: none"> <li>▪ This is really recommended because when physical inspection will be done to</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ The whole export process is very detailed and exhaustive since different procedures should be done at different government offices, all vehicle information, owner, id number, motor number should be the same in all paperwork and custom system, if not, corrections will have to be done in customs system and extra charges will apply.</li> <li>▪ The original documents are required at least 14 working days before desired sailing, first scanned by email so the broker can check them and then originals and vehicle at least one week before sailing.</li> <li>▪ 7 days before sailing vehicle will be inspected by the DJJ office to check if actual motor number is the same as mentioned on the paperwork.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Once you deliver the vehicle to the removal company, note that the gasoline must be on ¼ or less.</li> <li>▪ For diplomatic vehicles, the process is longer, as the diplomatic office should provide first the Export Permit (Permiso de Reexportación) stamped by the custom central office.</li> </ul>

	<p>the vehicle and the number of the motor is not physically showed, the inspector will request an original certification of the motor by a car workshop.</p> <ul style="list-style-type: none"> <li>▪ Picture of motor number.</li> <li>▪ <b>Original</b> Power letters <ul style="list-style-type: none"> <li>▪ These will be provided by the removal agent.</li> <li>▪ Letters should be filled in computer, without the lines on the template and dated near the sailing date. The ID Number that must be on the letters is the ID that is mentioned on the Title of the Vehicle.</li> </ul> </li> <li>▪ <b>Original</b> Export Permit (Permiso de Reexportación) stamped by the custom central office – <b>only for diplomatic vehicles.</b></li> </ul>		
<b>Pets and animals</b>	<ul style="list-style-type: none"> <li>▪ <b>Original</b> Health Certificate stamped from a registered local vet, issued with 10 days before flight date.</li> <li>▪ <b>Original</b> Vaccine Certificate or Carnet</li> <li>▪ Passport copy of the owner.</li> <li>▪ Quarantine certificate by MIDA.</li> <li>▪ Pictures (2) of pet inside and outside the kennel.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Preparation and documents should be checked at least 2 weeks before flight.</li> <li>▪ Flight booking is allowed maximum 5 days before flight.</li> </ul>	<ul style="list-style-type: none"> <li>▪ There are certain breeds and ages that are restricted.</li> <li>▪ Client should provide kennel with absorption material (not newspaper), with two plates, water bottle and food in Ziploc bag, lash, and collar.</li> </ul>
<b>Prohibited Items</b>	<ul style="list-style-type: none"> <li>▪ Liquid fuel</li> <li>▪ Explosives</li> <li>▪ Archeologic items</li> <li>▪ Fossils</li> <li>▪ Compressed gas</li> <li>▪ Matches</li> <li>▪ Spray cans</li> <li>▪ Poison</li> <li>▪ Electronic cigarettes, cigars, electronic pipes and hookahs, personal vaporizers, electronic</li> </ul>	<ul style="list-style-type: none"> <li>▪ Firearms, ammunitions, and weapons.</li> <li>▪ Pharmaceuticals and medicine.</li> <li>▪ Any kind of food.</li> <li>▪ Psychotropic drugs.</li> <li>▪ Toxic waste.</li> <li>▪ Fertilizer.</li> <li>▪ Flammable, chemical products</li> <li>▪ Plants.</li> <li>▪ Seeds</li> <li>▪ Printer cartidges</li> </ul>	<ul style="list-style-type: none"> <li>▪ Corrosives, lithium batteries, hoverboards are prohibited in air shipments.</li> <li>▪ Lithium batteries should be removed from the device in case of laptops, tablets we recommend client take these with him/her.</li> <li>▪ Inflatable elements must be without air (balls, inflatable mattresses)</li> <li>▪ Knee defender prohibited in air shipments.</li> <li>▪ Candles</li> </ul>
