<b>Removal Goods – Diplomatic HHG/ PE</b>	<ul style="list-style-type: none"> <li>▪ Copy of diplomatic ID stamped by the organization or embassy</li> <li>▪ Copy of passport stamped by the organization or embassy</li> <li>▪ Stamped packing list by foreign affairs</li> <li>▪ Export letter from Foreign Affairs</li> <li>▪ Authorization letter to our company, stamped by the organization or embassy and Ministry of Foreign Affairs (MOFA)</li> <li>▪ Copy from E-Ticket</li> </ul>	<ul style="list-style-type: none"> <li>▪ If shipment is full diplomatic, no approvals will be required and container will not be opened</li> <li>▪ If shipment is half/semi diplomatic, for any paintings/artworks, ministry of culture approval will be required</li> <li>▪ Old/valuable Antiquities, Historical or Heritage, Khan El Khalili Pharaonic Items are restricted.</li> </ul>

<b>Live Animals/Pets</b>	<ul style="list-style-type: none"> <li>▪ Veterinary Health Certificate</li> <li>▪ Vaccination Certificate</li> <li>▪ Original Passport and power of attorney or owner to be present on the day of export</li> </ul>	<ul style="list-style-type: none"> <li>▪ Requirements: <ul style="list-style-type: none"> <li>▪ IATA approved cage &amp; its dimension.</li> <li>▪ Weight of the animal &amp; weight of the cage</li> <li>▪ Breed</li> <li>▪ Name and address at destination so Airline can contact and get approval</li> </ul> </li> </ul>
