<p><b>Household Goods-HHG/PE</b></p>	<ul style="list-style-type: none"> <li>▪ Necessary items for exporting unaccompanied articles are as follows:                             <ul style="list-style-type: none"> <li>▪ A copy of shipper's passport (pages with photo and personal data)</li> <li>▪ A copy of shipper's flight coupon, or travel itinerary (issued by travel agency)</li> <li>▪ An Overseas Removals Agreement (application form showing shipper's contact address and telephone number)</li> <li>▪ Packing list/Inventory</li> <li>▪ Other paperwork, if applicable (Documents required by Customs and authorities at destination)</li> </ul> </li> </ul>		
<p><b>Prohibited or restricted items</b></p>		<ul style="list-style-type: none"> <li>▪ These items are prohibited to export:                             <ul style="list-style-type: none"> <li>▪ Plants and animals listed in the Washington Convention</li> <li>▪ Firearms, swords, ammunition, and other weapons</li> <li>▪ Hazardous goods (sprays, thinner, matches, oxidizers, etc.)</li> <li>▪ Lithium ion battery</li> <li>▪ Combustible goods</li> <li>▪ Live plants and seeds</li> <li>▪ Perishable Food</li> <li>▪ Items prohibited for each country / city. (Please refer to customs information).</li> <li>▪ Counterfeit, altered, or imitated coins and paper money, banknotes, or securities.</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ These items are not acceptable to export:                             <ul style="list-style-type: none"> <li>▪ Valuables (Gold, jewellery, credit card, things that cannot be replaced etc.)</li> </ul> </li> </ul>
