We would like to bring to your attention the dangers that can arise from packing certain common household products in your shipment, as well as to inform you that federal law prohibits the packing of hazardous and restricted items in any shipment.</li> <li>▪ Many common household items, including aerosol hair spray and cleaning products, are very hazardous when packed. Heat quickly builds up inside the containers, which can trigger an explosion or fire that can not only cause serious damage to a shipment, but endanger the lives of passengers/transporters as well. Therefore, for everyone's safety, please make sure none of the items on our partial list below, are packed in a shipment to be moved. <b>Vehicles for diplomats</b>	<ul style="list-style-type: none"> <li>▪ Copy of your ID card with stamp</li> <li>▪ ORIGINAL import Customs Declaration Form</li> <li>▪ Application Letter &amp; Power of Attorney: <ul style="list-style-type: none"> <li>▪ Provided by your agent after they receive your copy of your car registration card.</li> <li>▪ You will need to print the letters on your Embassy /organization letterhead - 2 copies for every shipment.</li> </ul> </li> </ul>
