<p>Personal Effects</p>	<ul style="list-style-type: none"> ▪ Foreigners <ul style="list-style-type: none"> ▪ Copy of passport ▪ Valued inventory ▪ Original certificate of change of residence and original letter of appointment from employer in Niger ▪ Application for duty-free admission must be addressed either to the shipper's embassy in Niamey (it will take at least 3 weeks) or to customs department (it will take at least 2 weeks) ▪ Detailed list of electrical appliances and Hi-Fi's, not older than 6 months ▪ Non-sale certificate. ▪ Diplomats or U.N. or E.U <ul style="list-style-type: none"> ▪ Copy of diplomatic passport ▪ Valued inventory ▪ Original certificate of change of residence and original letter of appointment from the employer ▪ Application for duty-free admission ▪ Taxes and duties exemption certificate. ▪ Returning citizens <ul style="list-style-type: none"> ▪ Copy of passport ▪ Valued inventory 	<ul style="list-style-type: none"> ▪ Statistical tax of 3% of the value of the goods will need to be paid despite the presence of a certificate of departure (air or sea export) ▪ Only one item per category is allowed (e.g. 1 TV, 1 fridge, etc.) ▪ The original certificate of change of residence shall mention length of stay, address on upon arrival as well as arrival date ▪ The following duties and taxes will have to be paid for non-exempted personal effects: <ul style="list-style-type: none"> ▪ Duties and taxes: 47,37% on the value declared to customs ▪ 30 000 FCFA of administration fees ▪ 30 000 FCFA on scanner fees. ▪ Even if personal effects are exempt from taxes and duties, the following fees will apply: <ul style="list-style-type: none"> ▪ 30 000 FCFA of administration fees ▪ 30 000 FCFA on scanner fees. ▪ Duty-free admission application must be addressed either to the Ministry of Foreign Affairs (it will take at least 4 weeks) or to Customs department (it will take at least 2 weeks) ▪ Exemption certificate could take 2 to 3 weeks.

<p>Motor vehicles</p>	<ul style="list-style-type: none"> ▪ Original car registration documents ▪ Insurance certificate ▪ Non-sale certificate 	<ul style="list-style-type: none"> ▪ The following duties and taxes will have to be paid for non-exempted vehicles: <ul style="list-style-type: none"> ▪ Duties: 47.60% of the CIF value ▪ Taxes: 0.25% of the CIF value (guarantee fund) ▪ 30 000 FCFA for admin fees. ▪ 120 000 FCFA for SONILOGA, agency estimate of the argus value on all exempt and non exempt vehicles ▪ 30 000 FCFA for scanner fees. ▪ For exempted vehicles, the following will be applied in accordance with a particular class of customers: <ul style="list-style-type: none"> ▪ First category: NGO <ul style="list-style-type: none"> ▪ Duties: 3.25 % of the CIF value ▪ 30 000 FCFA for admin fees ▪ 30 000 FCFA for scanner fees. ▪ Second category: PROJECTS <ul style="list-style-type: none"> ▪ Duties: 1.25 % of the CIF value ▪ 30 000 FCFA for admin fees ▪ 30 000 FCFA for scanner fees. ▪ Third category: Embassies, consulates, U.E. <ul style="list-style-type: none"> ▪ 30 000 FCFA for admin fees ▪ 30 000 FCFA for scanner fees.
