If import permissions are required, add more days depending on the kind of permissions.

Once it is confirmed the clearance may take app. one week.

Upon arrival of the shipment the account should apply for duty free import and the process may take about 10 days.

The amount depends on the peculiarities of the car 	<ul style="list-style-type: none"> ▪ The clearance process may take about 2 days.
