However, all agents and all involved in the organization of cargo import to Russia should be aware that the weight of the shipment must be rational and consistent with value. Before packing, it is important to consult with an agent in the country of destination regarding the weight of the shipment and its value. The consignee of the shipment can make payment of import duties customs either from their bank account, in cash in the bank office or through online banking. Any Russian citizen can import personal effects on a duty-free basis if the goods are worth up to five thousand Euro and the consignee has a letter from the Consulate of the Russian Federation confirming his/her registration in the Russian Consulate in the country of stay for more than 1 year.
