Copies of the supporting export documents will be needed.</li> <li>▪ Only 1% of duty is charged based on CIF value.</li> <li>▪ Deadline to Import goods: the shipment(s) should arrive in conjunction with, or within 120 days before or after the beneficiary's arrival in the country. All shipments will require an additional thorough inspection performed by the moving company at airport facilities. This is additional to the Customs inspection that is always performed. Detailed Packing list:</p> <ul style="list-style-type: none"> <li>▪ Like some other countries, Chilean Customs Authorities are requesting a fully detailed packing list, especially with clothing, electronics and wooden items. This request is mandatory for all air shipments regardless the weight.</li> <li>▪ Wooden items must be indicated in the Packing list (furniture, ornaments, picture or painting frames, among others).</li> <li>▪ A detailed item by item list is required. For example, the clothes must indicate the number of pants, shirts, shoes, etc.</li> <li>▪ Electronic devices must indicate type, brand name, model and serial number.</li> <li>▪ If the goods are placed in 2 or more crates, the packing list must indicate which items are in which crate.</li> </ul>

		<p>materials used for the transport of goods.</p> <ul style="list-style-type: none"> <li>Shipments into or out of the country in wooden packaging, need to have a Seal, certifying that the shipment has received the required treatment (HT = Heated Treatment [a minimum wood core temperature of 56°C for a minimum of 30 minutes] or fumigation with Methyl Bromide (MT).</li> <li>The minimum temperature should not be less than 10°C and the minimum exposure time should not fall below 16 hours.</li> <li>The treatments established in the present regulation have the intent to reduce the introduction and/or the dissemination of quarantine plagues associated to the wood packing.</li> <li>The wood packing material must be marked in a visible location on each article, on at least two opposite sides of the article with a legible and permanent mark in black ink.
