<p>Removal goods</p>	<ul style="list-style-type: none"> ▪ Original change of residence certificate issued by local authority from country of departure. ▪ Valued inventory in French or Arabic. ▪ Packing-list detailed dated and signed. ▪ Work contract or original attestation from Moroccan company. ▪ Copy of passport with stamp of entry Morocco. ▪ Sworn Statement stating these are used goods (original doc required) + POA with legalized signature (template given by Moroccan mover). ▪ List of prohibited items signed from customer 	<ul style="list-style-type: none"> ▪ Duty free entry if goods have been in owner's possession and used for more than 6 months. 	<ul style="list-style-type: none"> ▪ For Return Moroccan <ul style="list-style-type: none"> ▪ Moroccan Consulate must stamp same documents in place of departure for Moroccan people. ▪ Attestation of return definitively from Moroccan Embassy ▪ CCR has to be on city hall's paper head, signed and stamped. ▪ CCR can be done in most consulates / embassies in Morocco. Check with your destination agent before departure.
<p>Diplomats' removals</p>	<ul style="list-style-type: none"> ▪ Franchising delivered by Ministry of Foreign Affairs in Rabat (in French). ▪ Inventory in French or Arabic, stamped by the diplomatic entity. ▪ Copy of passport. ▪ Power of Attorney, on diplomatic entity letterhead and stamped. ▪ Sworn Statement, on diplomatic entity letterhead and stamped. ▪ Verbal note (from a diplomatic entity). 	<ul style="list-style-type: none"> ▪ Duty free entry even for new furniture. ▪ For alcohol, see under the wine/alcohol section.

Wedding trousseaux	<ul style="list-style-type: none"> ▪ Wedding certificate. ▪ Original certificate of change of residence. ▪ Inventory in French or Arabic. ▪ Proof of residence in Morocco for your husband/wife. ▪ Power of Attorney, legalized signature. ▪ Sworn Statement, original letter required. 	<ul style="list-style-type: none"> ▪ Duty free entry except for new items. 	
Inheritance	<ul style="list-style-type: none"> ▪ Notary act giving name of the deceased and his family relationship with the heir. ▪ Inventory delivered by notary. ▪ Copy of heir's passport. 	<ul style="list-style-type: none"> ▪ Same as above. 	
New articles	<ul style="list-style-type: none"> ▪ New articles invoice. ▪ Packing List. 	<ul style="list-style-type: none"> ▪ Subject to duty and taxes. 	<ul style="list-style-type: none"> ▪ Depends on items' category. ▪ You can count on 50 % more or less.
Antiques, works of art	<ul style="list-style-type: none"> ▪ Detailed and valued inventory. ▪ Authorisation issued by Ministry of the Cultural Affairs. 	<ul style="list-style-type: none"> ▪ Duty free entry when used and part of removal goods. 	
Motor vehicles, motor cycles, boats, caravans	<ul style="list-style-type: none"> ▪ Original of title certificate. ▪ Original passport. ▪ Purchase invoice. 	<ul style="list-style-type: none"> ▪ Diplomats: <ul style="list-style-type: none"> ▪ Free entry with franchising letter. ▪ Whether used or new car. ▪ Non diplomats: <ul style="list-style-type: none"> ▪ Temporary import: <ul style="list-style-type: none"> ▪ Free if car is less than 5 years old. ▪ Temporary import is limited to 6 months per calendar year. ▪ Regular import: <ul style="list-style-type: none"> ▪ Around 50 % taxes and duties. ▪ Car has to be less than 5 years old. 	<ul style="list-style-type: none"> ▪ Only diplomats can import a car older than 5 years old.

Dogs and cats	<ul style="list-style-type: none"> ▪ Certificate of vaccination (vaccination against rabies required for dogs only). ▪ Health certificate. ▪ Owner's passport copy. 		
Plants	<ul style="list-style-type: none"> ▪ Phytosanitary certificate. 		<ul style="list-style-type: none"> ▪ Avoid plants because the authority delivering the certificate is complex and slow.
Hunting arms	<ul style="list-style-type: none"> ▪ Hunting permit. ▪ Firearm acquisition certificate. 	<ul style="list-style-type: none"> ▪ Duty free entry when used and part of removal goods. 	<ul style="list-style-type: none"> ▪ If documents are not produced, arms will be retained at customs.
Books, records, cassettes			<ul style="list-style-type: none"> ▪ No list required.
Wine, alcohol		<ul style="list-style-type: none"> ▪ 25 to 30 bottles admitted as "fond de cave" if part of your removal. ▪ What is allowed for a foreigner: <ul style="list-style-type: none"> ▪ 15 "opened" bottles (e.g., opened whisky bottle) + 15 unopened bottles. ▪ Indicate 'fond de cave' on the packing list. ▪ What is allowed for a diplomat: <ul style="list-style-type: none"> ▪ 19 boxes of alcohol (pack of 6 or 12 bottles). ▪ Indicate 'fond de cave' on the packing list. 	<ul style="list-style-type: none"> ▪ Bottles cannot be in new cases. They have to be bought some time ago.
Narcotics, drugs		<ul style="list-style-type: none"> ▪ Prohibited entry. 	
Tins & food		<ul style="list-style-type: none"> ▪ Small quantities admitted as part of removal goods. 	<ul style="list-style-type: none"> ▪ Avoid canned food and pet food, customs can request analyse from agricultural ministry which costs time and money.

Books and magazines: Pornographic and Politics against Morocco's kingdom + islamophobics		<ul style="list-style-type: none"> ▪ Prohibited entry. 	<ul style="list-style-type: none"> ▪ Maps showing the southern provinces of Morocco separated from the northern ones and named Western Sahara will be confiscated.
Cellular or cordless telephones, fax machines, satellite talkie-walkie	<ul style="list-style-type: none"> ▪ A declaration/certificate has to be made to authorities ONTT and "Maroc Telecom". 		
Drones		<ul style="list-style-type: none"> ▪ Prohibited entry. 	<ul style="list-style-type: none"> ▪ Any flying objects without pilot are to be considered as drone, even kids toys.
